At the November meeting, Rebecca will discuss print media and how it is alive and growing. She will also discuss the role of journalism in the Internet age and MDDC's initiatives to safeguard freedom of information and government transparency. Rebecca will also share innovative initiatives by print media companies to keep up with consumer and advertising demands.


